 - Precious shipments: The received data will be used exclusively for the provision of the requested service and for the time necessary to provide the service.
 - All-Risk insurance: The data concerning you will be processed/retained according to the following criteria: for a period not exceeding that
 necessary to achieve the purposes for which they are processed; for a period not exceeding that necessary to comply with legal obligations.

DATA SUBJECT RIGHTS

- 6. Pursuant to European Regulation 679/2016 (GDPR) and current national legislation, the data subject can exercise the following rights, within the limits and according to the procedures provided by the current legislation:
 - to obtain confirmation of the existence of personal data concerning them (right of access of the data subject Article 15 of Regulation 679/2016);
 - to know its origin;
 - to receive intelligible communication;
 - to have information about the logic, methods, and purposes of the processing;
 - to request updating, rectification, integration, erasure, anonymization, or blocking of data processed in violation of the law, including data that is no longer necessary for the purposes for which it was collected (right to rectification and erasure Articles 16 and 17 of Regulation 679/2016);
 - the right to restrict and/or object to the processing of data concerning them (Articles 18 and 21 of Regulation 679/2016);
 - the right to revoke consent;
 - the right to data portability (Article 20 of Regulation 679/2016);
 - in cases of processing based on consent, to receive their data provided to the data controller, in a structured, commonly used, and machinereadable format and to transmit this data to another data controller without hindrance;
 - the right to lodge a complaint with the supervisory authority (right of access of the data subject Article 15 of Regulation 679/2016).
